Subject: Revival of tubewell connections cancelled due to falling in notified area.

Reference: SE/OP Circle-I, DHBVN, Gurugram bearing E-office file No. DHBVN-280004/27/2023.

In reference to Sales Circular No. D-36/2021 and regarding release of tubewell connections in the notified area. As per ibid circular, such applicants those have been cancelled by the sub division at the initial stage on the pretext of notified area shall also be given equal opportunity by reviving them by the concerned SE (OP).

In this context, requests has been received from XEN/OP, Manesar for revival of 351 tubewell applications cancelled due to falling in notified area during January,2019 & December,2021. Accordingly, the matter was put up to the management and it has been decided as under:-

- A one-time window for the duration of one month may be allowed for the revival of such cancelled tubewell applications between January, 2019 & December 2021.
- Concerned SDO/OP shall personally examine such cancelled applications and issue notices to all such applicants for revival of their cancelled application.
- XEN/OP Shall be nodal officer for spearheading the whole process for giving opportunity to all such applicants.
- All such cancelled tubewell application shall be revived as per prevailing Nigam's instructions/guidelines.

- Concerned SDO/OP shall promptly issue the notice to such application by 29.02.2024 whose tubewell application got cancelled due to falling in notified area to apply for the revival of their applications .
 - Consequently, one month window for revival of such applications will be open from 01.03.2024 to 31.03.2024. After that revival requests of such applicants will not be entertained.

The above instructions should be brought to notice of all concerned for meticulous compliance.
